In recent times, the researcher/practitioner partnership has continued to grow in frequency. This is especially true as funding agencies often require an evaluation of implemented programs to determine if their money is being spent appropriately. This breakout session will cover different aspects of the researcher/practitioner partnership. Secondly, the concept of "action research" will be discussed to understand the importance of having researchers at the table when practices are being designed and implemented in a real world setting. Finally, we will highlight the importance of using data, through current and past projects, and how it impacts the criminal justice system.

Housing affordability is a challenge for many households throughout South Florida. As housing prices continue to rise a significant percentage of the population is either cost burdened, defined as paying more than 30% of monthly income towards housing costs, or severely cost burdened in that they pay over 50% of their income in housing costs. No population faces a greater challenge to housing affordability then those reentering society from prison who lack a family support network and face numerous financial and discriminatory burdens to accessing housing. The panel will discuss some of the challenges of providing housing opportunities to those exiting the prison system and possible solutions to opening up housing options for this population.

This year more than 700,000 individuals will leave the confines of incarceration and return to the imminent reality of their local neighborhoods and communities. A diverse panel of reentry advocates and individuals with lived experience will share their successes and challenges of traveling "The Road Home.

## GENDER SPECIFIC, TRAUMA-INFORMED RESPONSES FOR JUSTICE INVOLVED WOMEN

The criminal justice system has seen a rise in the incarceration of women, whose entry into the criminal justice system is often more complex than their male counterparts (Allen, 2018). Women account for nearly 7% of the prison population and are one of the fastest growing sectors of the population facing incarceration in recent years (Allen, 2018). Pragmatic changes that account for gender responsive programming can assist in ameliorating the complex changes experienced by women to reduce recidivism (Morash, Bynum, & Koons, 1998). Effective gender responsive programs creates a sense of safety by careful site selection, staff selection, and program development that assists in facilitating strengths and addresses challenges faced by justice involved women (Covington & Bloom, 2007). This presentation will illustrate how trauma-informed, gender responsive, restorative, community supervision of justice-involved women plays a role in reducing recidivism and how partnering agencies and community members can support this work.

We tend to be good at meeting the technical challenges of managing our agencies, but often have difficulty rising to the adaptive challenges of leadership and change that call for new skills, new mindsets and risk taking or getting out of our comfort zone. This session will engage you in a versatile and effective process for developing ourselves and our staff as leaders who are able to meet the more difficult adaptive change issues facing us today; how to support and challenge ourselves to get to a level of staff and organizational competence that results in demonstrable benefits and change in the lives of our staff, clients and communities. This process works across all staffing and client levels and develops senior managers, mid-level managers/ supervisors, line-staff and clients.

Bogue and O'Connor have been co-creating and implementing this system with seven different county community corrections agencies in Minnesota and Oregon with great results. Staff find it fun, meaningful and doable. It is not a "top down" process, but rather a "top supported, bottom up" approach that starts with the top management learning, practicing and modeling a developmental coaching system with their mid-level managers who then pass it on to their line-staff, who then pass it on to their clients, who then pass it on their families and to other clients. We will tell you the story and outcomes of our journey with these agencies, and show you the promise this journey holds for inspiring a new vision for community corrections.

The County has successfully cut rearrest rates in half for those involved in programming. The session will provide information on how to engage the community as three of the key stakeholders will provide information on organizational structure, vision, implementation, partnerships, funding, overcoming obstacles, data collection and sustainability.

#### IMPROVING EMPLOYMENT OUTCOMES FOR PEOPLE FORMERLY INCARCERATED: DEVELOPING A PATHWAY TO SUCCESS 10:30 - 11:45 AM

Employment is an essential component to successful reentry. When people returning to the community from incarceration seek work many face barriers, such as behavioral health needs and housing instability, making it difficult to connect to sustainable employment. This population may also experience skill deterioration, employer bias and lack of access to pro-social networks. This session will highlight effective approaches for eliminating barriers to obtaining and maintaining employment. Specifically, employment service providers and correctional professionals will learn about strategies for addressing a person's assessed risk to reoffend and associated need factors through research-driven and best practices. The presenters will discuss the importance of providing supportive services to promote stabilization. They will also provide guidance on building employability skills and engaging employers in the hiring of people formerly incarcerated.
